**Complaint in the case of:**

Title: Mohammad Ramzan Bhat v/s PIO SDA Srinagar

This is a complaint filed by Shri Mohammad Ramzan Bhat s/o Mohammad Shaban Bhat r/o Wazir Bagh, Srinagar against PIO Srinagar Development Authority (SDA) stating that he had sought information from PIO on 02.04.2015 under J&K RTI Act, 2009 but till date, the respondent has failed to provide the requisite information. It is alleged that the complainant made several rounds in the office of respondent and on 11.05.2015, the respondent in open office refused to provide information as required by him. The complainant has accordingly requested the Commission that legal action as warranted under law may kindly be taken against the respondent.

In reply to the notice of the Commission, PIO vide letter dated 27.05.2015 submitted that reply in the matter has already been given to the complaint vide office letter dated 4.5.2015 (copy enclosed). Perusal of the letter dated 4.5.2015 reveal that the information seeker has been informed that he himself has mentioned dispatch No. of the letter, copy of which has already been addressed to Assistant Commissioner (C) with Divisional Commissioner Kashmir under mentioned dispatch No. Thus the RTI application filed on 2.4.2015 has been responded to on 4.5.2015 and hence minor delay is only procedural.

During proceedings in the Commission today, Shri Mohammad Ramzan Bhat alleged that the letter under reference has not been received by the office of Assistant Commissioner (C) and by asking dispatch No. of the letter, he meant whether this letter has been officially delivered in the office of AC (C) and acknowledged as per procedure.

In view of clarifications given by the appellant, PIO is directed to intimate, as per records, whether letter bearing No. SDA/DLM/277 dated 22.04.2015 addressed to Asstt. Commissioner (C) Srinagar has been delivered and acknowledged by the concerned office or otherwise and intimate the same to the complainant, within 10 days. A compliance report in this regard be sent to the Commission.

With the above directions complaint filed before the Commission is disposed of.
