The Commission vide its order No. SIC/J/A/350/2015/28 dated: 27.04.2015 directed the PIO/Executive Engineer, PWD (R&B) Const. Division-II to furnish the requisite information to the information seeker, free of cost, within 10 days from the date of receipt of the order. The PIO was further directed to dispatch the information to the information seeker under a registered cover, at the residential address given in the RTI application under an intimation to the Commission.

The complainant filed a complaint under Section 15 of the Jammu & Kashmir Right to Information Act, 2009 in which he has alleged, inter-alia, that the PIO has failed to provide the information and did not care to respect the mandate of the Section 7 of the Jammu & Kashmir Right to Information Act, 2009.

The Commission after receiving the complaint for non-compliance listed the matter for hearing on 14.08.2015 and the Executive Engineer, PWD (R&B) Const. Division-II was directed to implement the order of the Commission and he sought 15 days time to do the needful. The matter was again listed for hearing on 11.09.2015. The Technical Officer to Executive

Engineer, PWD(R&B) Const. Division-II who appeared on behalf of the PIO apprised the Commission that the information as per the direction of the Commission has been dispatched to the information seeker and the information seeker also acknowledged the receipt of the same. However, the information seeker brought to the notice of the Commission that the entire information provided to him has not been duly authenticated by the concerned PIO, though the Commission had directed the PIO to provide duly certified copies of the information to the information seeker.

Sh. S.P. Manhas, Superintending Engineer, PWD (R&B) Circle Jammu, Samba, Kathua/First Appellate Authority assured the Commission that as per the directions of the Commission, authenticated copies of the information will be refurnished and sought 3 days time to do the needful, as the PIO/Executive Engineer, PWD(R&B) Const. Division-II is out of station.

In view of the assurance given by the First Appellate Authority/Superintending Engineer, PWD (R&B) Circle Jammu, Samba, Kathua, the Commission directs him to provide the duly authenticated copies of the entire information sought by the information seeker within 03 days from the date of pronouncement of this order under an intimation to the Commission.

The complaint for non-compliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
