Brief facts of the case are that appellant filed Second Appeal on 08.03.2016 stating that he requested PIO Revenue Department Kupwara on 09.12.2015 for providing information i.e., name of persons in respect of rent since 1947 for land under Survey No. 880 situated at Gund Zonaresh Kralpora presently under occupation of Army, but PIO failed to provide information within the prescribed period. That he preferred First Appeal before FAA/Deputy Commissioner Kupwara on 11.01.2016, but same was not provided despite lapse of more than 03 months.

Appellant has accordingly requested to advice concerned authority to provide information.

During proceedings in the Commission on 19.04.2016, PIO/ADC Kupwara was directed to forward copy of information received from Tehsildar Kupwara under letter No. TK/OQ/242 dated 27.01.2016 alongwith enclosures to the appellant. However, during proceedings in the Commission today, respondents clarified that this reply of Tehsildar Kupwara is in response to another RTI application and therefore not related to this case. PIO/Tehsildar Kralpora submitted that the information seeker has filed multiple RTI applications with the public authority seeking information on the same subject. He further submitted that in the present RTI application dated 03.12.2015, the appellant has sought name of person (owners of land) who have received rent since 1947 of Khasra No. 880 at Gund Zonareshi. This RTI application was transferred to Tehsildar Kralpora, who has responded it vide letter dated 29.12.2015 informing the appellant that information upto 2014 is not available in his office and as such Acquaintance Roll for the rent disbursed by his office in the year 2015 is available and is enclosed.

In so far as information prior to 2014 is concerned, ADC Kupwara drew attention of the Commission to letter dated 07.02.2016 from Tehsildar Kupwara, wherein it is stated that records prior to year 2015 could not be traced due to outbreak of fire in Tehsil office on 13.05.2005 and copy of FIR is enclosed. He has further submitted that information available as per records has been provided to the appellant vide letter dated 23.11.2015. The appellant admitted to have received Acquaintance Roll in respect of Khasra No. 880 for years 2005-2013, but pointed out over-writing in year to which it pertains. Accordingly, PIO/ADC Kupwara is directed to verify this allegation

and provide true and attested copy of the information to the appellant from the concerned Tehsildar.

The appeal filed before the Commission is disposed of with above directions.
