Decision: Appeal disposed of.

1. Brief facts of the case are that appellant filed 2nd appeal before the Commission on 29-03-2016, against the order of FAA and PIO, Crime Branch on his RTI application dated: 15-04-2015, wherein appellant has sought action taken on his complaint filed before SSP, Crime Branch dated: 18-11-2014, i.e., FIR, proceedings initiated, statements recorded and action against accused.
2. Mr. Najeeb Ahmad Nehvi, Sr. Prosecuting Officer, Crime Headquarters, PIO attended the hearing at Srinagar office. Appellant Shri Dharam Paul heard via video conferencing from Jammu office.
3. In compliance to the notice of the Commission, Mr. M.S.Chouhan, FAA/SO to IGP, Crime Branch Headquarters, J&K has filed reply/counter statement to the 2nd appeal dated: 10-05-2016, copy of which is marked to the appellant. The RTI application has initially been responded by Mr. Abdul Wahid, DSP, Crime Branch,

Jammu (PIO) vide his letter dated: 23-04-2015, wherein, appellant has been informed that his complaint has been sent to State Crime Branch, Headquarters for accord of approval vide communication dated: 22-11-2014 and subsequently, Crime Headquarters referred the matter to DIG, Jammu-Kathua range vide letter dated: 12-01-2015 for further necessary action, hence information can be had from the concerned quarters. Thereafter, PIO, State Crime Branch, J&K vide his letter dated: 18-06-2015 in reference to appellant's application dated: 13-06-2015 has informed him that " after conducting discreet enquiry in the matter, the same has been closed and consigned to records".

4. The first appeal filed before FAA has been decided by FAA, Mr. M.S.Chouhan, S.O. to IDG, Crime Branch Headquarters, J&K vide order dated: 30-01-2016, concluding that FAA is satisfied and agreed with reply of the PIO dated: 19-01-2016 and accordingly appeal has been dismissed.

5. During proceedings in the Commission, PIO submitted that copy of enquiry report has been provided to the appellant, who acknowledged the receipt of same.

6. In view of the above, no further action is warranted on this appeal, as per provisions of the RTI Act. Hence, appeal filed before the Commission is disposed of.
