1. Brief facts of the case are that appellant filed 2nd appeal before the Commission on 12-04-2016, against alleged inaction of PIO and FAA on his RTI application dated: 29-12-2015 and first appeal dated: 15-02-2016 . Appellant in his 2nd appeal has made a prayer before the Commission that information be provided to him
2. Mr. Mohammad Amin Malik, ADC-cum-FAA, O/o Deputy Commissioner, Doda and Mr. Dil Mir, SDM, Gandoh /PIO heard via video conferencing from NIC office Doda. Appellant Mr. Tariq Hussain Shiekh attended the hearing at Commission Office, Srinagar.
3. In compliance to the notice of the Commission, FAA/PIO have filed reply / counter statement dated: 12-05-2016, wherein, FAA has submitted that first appeal dated: 15-02-2016 filed by the appellant was received in his office on 19-02-2016, wherein appellant had plead that he had sought information from SDM/PIO, Gandoh, under RTI, which was not been provided to him. Accordingly a rebuttal report was

sought from SDM, Gandoh/PIO, vide FAA's letter dated: 23-02-2016. That after receipt of rebuttal report from SDM, Gandoh/PIO, it was noted that RTI application dated: 29-12-2015 was received in the office of PIO on 16-01-2016. That SDM, Gandoh /PIO vide his letter dated: 28-01-2016 responded to the RTI application and asked appellant to deposit Rs. 260/- as copying charges. Accordingly, first appeal was decided by FAA vide order dated: 27-03-2016, wherein, PIO was directed to provide information to the information seeker, after receipt of copying charges.

4. Appellant admitted that after depositing requisite copying charges, information has been provided to him vide SDM, Gandoh/PIO's letter dated: 31-03-2016.

5. In view of the above, appeal filed before the Commission is disposed of.
