Brief facts of the case are that appellant filed Second Appeal before the Commission on 21.04.2016 stating that an application dated 30.12.2015 was submitted to PIO/Executive Engineer, PHE Division Akhnoor for providing information regarding list of vehicles (water tanners/Tata Mobile) which availed payment of hire charges from 28.08.2013 to 20.10.2015 and under which scheme. That he filed First Appeal before XEN PHE Division on 04.03.2016, which is still pending before him and no reply has been furnished to the applicant till date. The appellant has prayed the Commission for initiating action under RTI Act and directions to PIO to furnish the relevant information under the provisions of the Act.

In reply to the Second Appeal, FAA/Superintending Engineer, Hydraulic Circle, Jammu submitted reply/counter statement vide letter 14.05.2016 stating that in response to First Appeal he directed

PIO/Executive Engineer, PHE Division Akhnoor vide letter dated 11.02.2016 to furnish the requisite information to the appellant directly. That in response, PIO furnished information to the appellant vide his letter dated 27.02.2016.

Er. R.K. Gupta FAA/SE Hydraulic Jammu, Er. Vijay Gupta PIO/Xen and appellant attendant the hearing from Jammu office. The appellant admitted to have received the information dated 27.12.2016 from PIO under which details of payments on account of POL for Tankers/Tata mobiles for the period June 2015 to January 2016 have been given. PIO submitted that information in respect of Points 2 & 3 have been clubbed together and provided in the shape of format under letter dated 27.02.2016. However, it is observed that information sought at Point-1 i.e. details of list of vehicles i.e., water tankers/Tata Mobile w.e.f. 28.08.2013 to June 2015 have not been provided. PIO submitted that this information shall be provided within 2 weeks.

Therefore, appeal filed before the Commission is disposed of with the directions to PIO/Xen PHE Division, Akhnoor to provide remaining information to the appellant, and file a compliance report before the Commission.
