Decision: Appeal disposed of.

1. Brief facts of the case are that appellant filed 2nd appeal before the Commission on 02-05-2016 on the ground that BDO/PIO, Dali-Udhyanpur did not provide him information sought vide application dated: 23-11-2015, on the plea that report of concerned Patwari (Revenue) reveals that appellant is living separately from father since 2014-15 and his Chola-Chowkidra have been registered at S.No. 221 in the Revenue Record, hence, appellant to deposit Rs. 7000/- as Photostat charges. Appellant was further informed that in case he is found to belong to BPL category, his payment shall be refunded. That first appeal filed before ACD, Doda was decided by Mr. Sushil Kumar, ACD, Doda vide order dated: 02-02-2016 with directions to the BDO, Dali-Udhyanpur to call appellant in his office and let him inspect the record demanded by him. Thereafter, provide him copies of record, which appellant would identify during inspection.

2. Mr. Sushil Kumar, ACD, Doda/FAA, Ms. Mehmooda Begum, BDO, Dali-Udhyanpur, PIO and the appellant Mr. Habibullah Naik heard via video conferencing from NIC, Doda.

3. At point 1 of RTI application, appellant has sought details of all works of pacca path executed in Panchayat Kalihand for the year 2012-13 and 2013-14, which is specific. Therefore, BDO, Dali-Udhyanpur is directed to provide information at point 1, along with payments made for these pacca paths and details of skilled and unskilled labourer engaged on these works. Besides, BDO is directed to provide information at point 2, i.e., copy of plan and information at point 6, i.e., list of works /projects completed during 2012-13 and 2013-14. In so far as, other information is concerned, appellant has not specified any work. It is therefore implied that information has been sought with regard to payment made, purchases and copies of bills/vouchers for all works under taken by the department for the year 2012-13 and 2013-14. The Commission is of the view that compiling such information shall disproportionately divert resources of the Public Authority. Therefore, information seeker may seek details of payment of specific works only after going through plan and list of works completed.

4. ACD/FAA, Doda and BDO/PIO, Dali-Udhyanpur to comply above directions within 10 days and compliance report be filed before the Commission within two weeks.

5. In view of above, appeal filed before the Commission is disposed of.
