1. Brief facts of the case are that appellant filed Second Appeal before the Commission on 24.05.2016, stating that he sought month wise details of consumption in respect of his installation from AE EM&RE Sub-Division, Bari Brahmana through RTI application dated 20.01.2016 but there was no response from the PIO/AEE. That he submitted First Appeal before Executive Engineer EM&RE Division Vijaypur (Samba) on 27.02.2016, but there has been non-response from the FAA. The appellant has prayed the Commission for suitable directions under the Act, for providing the required details.

2. Mr. Sunil Kumar, APIO/AEE EM&RE Sub-Division, Bari Brahmana and Mr. Hem Raj, representative of the appellant attended the Jammu office of the Commission and heard via Video Conferencing.

3. In response to notice of the Commission, APIO/AEE EM&RE Sub-Division, Bari Brahmana has filed reply/counter statement dated 03.06.2016 interalia submitting that the appellant applied for details of his billing w.e.f. 1999 to 12/2015 on 201.01.2016. That the information demanded by the appellant was covering a long period and computerized billing was started in the Sub-Division in the month of April 2011 and prior to that there was ledger system. That information was subsequently provided to the appellant through special representative. APIO has enclosed 16 leaves of billing demand of the appellant.

4. The Commission perused the information and found that AEE has provided computerized generated copy of the bills. The representative of the appellant admitted receipt of the information and submitted that information asked for in the RTI application has been provided to him.

5. In view of above, appeal filed before the Commission is disposed of.
