**Brief Facts:**

Brief facts of the case are that Appellant fled second appeal before the Commission stating that he applied to Assistant Commissioner Revenue on 17.02.2016 seeking information under RTI Act regarding status of his application dated 14.07.2014 for issuance of Social Caste Certificate. That he received a reply from Tehsildar under RTI Act vide letter dated 22.03.2016, whereunder Tehsildar informed that his case has been referred to Secretary Advisory Board. When he approached the Secretary Advisory Board, he could not find the said application. Thereafter, he filed a First Appeal before SDM Srinagar on 30.02.2016, to which he received reply from SDM on 28.04.2016. On perusal of the reply of the SDM, it was found that he has not investigated why the application of the applicant was pending for a long time. In view of the above, he has requested the Commission to take necessary action and provide information sought.

Mr. Shafiq Ahmad Wafai, Tehsildar (North) Srinagar attended the hearing today on 07.09.2016. Although notice was send to the appellant, but he did not attend the hearing.

As per records enclosed with the appeal, PIO/Tehsildar (North) Srinagar has informed the applicant vide letter dated 22.03.2016 that matter has been taken up with Secretary State Advisory Board J&K Jammu vide letter dated 08.03.2016 , but that till date no report has been received in this behalf. He has also enclosed copy of letter dated 08.03.2016 addressed to Secretary, State Advisory Board J&K Jammu. This information has been received by the applicant as has been admitted by him in his Second Appeal. Thereafter, SDM (East) Srinagar has disposed of the First Appeal vide letter dated 28.04.2016 informing the appellant regarding status of his caste as per Intikhab Jamabandi/Shajra Nasab/other records. Copy of this communication has also been received by the appellant as admitted by him in the Second Appeal.

As per provisions of the RTI Act, the PIO is required to provide information as available on record, which in this case has been provided to him. Thereafter, the FAA also has given reply to the appellant on the basis of records as referred to by him.

In view of the above, the Commission did not found any merit in this appeal and is dismissed.
