The Commission received a complaint from Shri Parviaz Ahmad Misgar under RTI Act, 2009 stating that in compliance to the Information Commission's decision No.SIC/K/SA/19/2016/2003 Dated 11.04.2016, Tehsildar Eidgah was supposed to provide certified copies of Revenue Extracts Intikhaab, Intikaal and other and related documents under Khasra No.127, 128 and 129 w,e,f 2001 to 2015 and demolition order of Hon'ble High Court dated 14.11.2015. However, Tehsildar has provided him written copy of intikal on the back side of Revenue extracts, which is not based on revenue records as sought by him. He has accordingly requested to take action for non-compliance and provide the information as per RTI application dated 23.11.2015.

As per RTI application, dated 23.11.2015, on which complaint is based, the information sought by the complainant is revenue extracts "*of Khasra No. 127, 128*

*and 129 of Moza Khuchay Ceck w,e,f 2001 to 2015 and demolition orders of Hon'ble High Court.....”.*

In response to the notice of the Commission, dated 09.06.2016, Tehsildar Eidgah has submitted vide letter dated 11.06.2016 that requisite information has already been provided to the applicant and receipt of Shri Parvaiz Ahmad Misgar is enclosed.

As per documents enclosed with the reply of Tehsildar, Shri Parvaiz Ahmad Misgar has acknowledged receipt of revenue extracts certified by Naib Tehsildar Zadibal. He has also acknowledged receipt of orders from Hon'ble High Court dated 27.07.2011. Tehsildar has enclosed Intikhab Khasra Girdwarri for village Eidgah for Khasra No. 127, 128 and 129 and the extracts of Jamma Bandi are recorded as per records.

Mr. Syed Qawam-ud-Din, Tehsildar Eidgah, Mr. Mohammad Ashraf, Naib Tehsildar Zoonimar and complainant Shri Parvaiz Ahamd Misgar attended the hearing today on 21.09.2016.

Tehsildar submitted that record of Jamma Bandi are recorded in a large register, copying of which is not possible. Therefore, as per practice, authenticated extracts of entries in the Jama Bandi are given to the applicants. In so far as Khasra Girdwari is concerned, the copy of yearly entries can be made available. The plea of the Tehsildar is accepted and accordingly, Tehsildar Eidgah is directed to provide extracts of Jama Bandi and details of Intikhab Khasra Girdwarri w,e,f 2001 to 2015 to the complainant within two weeks.

The Commission has observed that Tehsildar has complied with the directions of the Commission by providing extracts of revenue records, which is

what the complainant has sought in his RTI Application. Therefore, no action is warranted against Tehsildar.
