Brief Facts:

The appellant Sh. Mansa Ram filed Second Appeal submitting that he filed RTI application dated: 08.03.2016, before PIO/BDO, Dansal seeking information on seven points related to annual plan and works sanctioned/done in the Panchayat Halqa Bhatyari and other information thereto for the period 2008 to 2016, but the PIO did not provide any information within stipulated period. That appellant filed First Appeal before the Director, Rural Development Department, Talab Tillo, Jammu on 09.04.2016. That vide letter dated: 18.04.2016 his First Appeal alongwith its enclosures was transferred to Sh. Shokat Mehmood Malik, Assistant Commissioner Development, Jammu/FAA for further necessary action, but till date no information as requested in the RTI application has been provided to the

appellant. In view of the above appellant has prayed before the Hon'ble Commission that FAA/PIO be directed to provide information as sought in application dated: 08.03.2016.

Sh. Shokat Mahmood, KAS, ACD, Jammu-cum-FAA, Sh. Zaheer Abbas, BDO, Dansal-cum-PIO and appellant Sh. Mansa Ram heard via Video Conferencing.

FAA submitted that the First Appeal has been disposed of by him vide order dated: 10.06.2016 with the directions to PIO/BDO, Dansal to provide the requisite information within 10 days from the date of issuance of the order on the address given by appellant.

BDO submitted that in an earlier case appellant sought similar information vide application dated: 18.10.2013, whereunder he had sought complete information for the period 2005-2013 regarding CD/Panchayat Head Funds granted every year, articles/goods/material funded by the Government, funds utilized from 03/2005 to 03/2013, labour used, job card holders used in MGNREGA and other related information regarding Panchayat Halqa Bhatyari, Block Dansal, Tehsil & District Jammu. This case has been decided by the Commission vide **Decision No. SIC/J/A/313/2013/19 dated: 23.01.2014**. BDO submitted that during proceedings in the Commission in the said case, appellant has expressed his satisfaction which statement is recorded at para 04 of the order of the Commission dated: 23.01.2014. BDO further submitted that information sought now from 2008-2016 includes the period upto 2013, for which the information has already been provided to him. Now he has recently provided information for the remaining period i.e., 2014-16 under letter dated: 13.06.2016 comprising of about 200 pages.

Appellant submitted that although he has received information. He however, submitted that information in respect of IAY and Sanitation programme has not been provided. The Commission, therefore, directs BDO, Dansal to provide information of IAY and Sanitation works for the period 2014-2016 undertaken in Panchayat Halqa Bhatyari, Block Dansal within two weeks and file compliance report before the Commission.

The appeal is accordingly disposed of with above directions.
