Brief facts of the case:

The appellant filed RTI application before PIO of the J&K Public Service Commission on 12-07-2016 seeking certain information under section 6 of the J&K RTI Act, 2009. Aggrieved by the inaction of the PIO in furnishing information, the appellant filed 1st appeal on 12-08-2016. First Appellate Authority of the J&KPSC too did not dispose of his 1st appeal, as such the appellant filed 2nd appeal before the Commission on 15-09-2016 against the failure of PIO & FAA in furnishing him the requisite information. In his 2nd appeal the appellant has requested the State information Commission to direct the PIO for providing him complete information. His 2nd appeal was listed before the Commission for hearing on 10-11-2016 and Commission passed an interim order directing the PIO to furnish him the requisite information within one week and file compliance report to the Commission.

Proceedings before the Commission:

During the hearing on 07-03-2017, which was attended by Shri Ishtiyag Ahmad, PIO, J&KPSC and Shri Narender Pal Singh (Appellant), the appellant filed written submission, that he has now received all the requisite information asked for by him and there was nothing pending and requested for withdrawal of his 2nd appeal. The PIO also submitted in writing that in compliance to the Commission notice dated 23-11-2016 all the information has been provided to the appellant. Submission of the parties is taken on record.

Decision:

In view of the submissions made by the parties, the State information Commission finds no legal impediment in acceding to the plea of the parties for withdrawal of the instant 2nd appeal with the rider that appellant is debarred from filing the 2nd appeal in future on the same RTI application.

Accordingly the 2nd appeal is dismissed as withdrawn.
