I. Brief facts of the case.

1. The Appellant Shri Varun Sawhney, Advocate, while exercising his Right to Information under section 6 of the J&K RTI Act, 2009 submitted RTI application with PIO O/o General Manager, TRC, Jammu on 24-10-2016 seeking information on 06 points regarding deductions made by the Corporation from the bills submitted by firms or the agencies providing cleaning/sweeping/housekeeping services from January'2012 to June'2015.
2. On being aggrieved from the inaction of the PIO, the appellant preferred 1st Appeal with FAA J&K Tourism Development Corporation, TRC, Jammu on 14-012-2016, which according to the appellant was also not disposed of by the FAA.
3. This constrained the appellant to file 2nd appeal with the Commission which was received on 16-02-2017.

II. Proceedings before the Commission.

1. The 2nd appeal came up for hearing before the Commission on 29-03-2017. The hearing was attended by Smt. Anju Gupta, General Manager(O)-cum-PIO, JKTDC and Appellant Shri Varun Sawhney, Advocate.

2. Appellant contended that he has not been provided the requisite information yet.
3. PIO submitted that information sought by the appellant is lying with her, she further submitted that one set of the information has been furnished to the Commission by Managing Director J&KTDC, Dr. Shahid Iqbal Choudhary, IAS vide No. MD/PS/1472-75 dated 08-03-2017.
4. Submissions of the parties were considered.

III. **Decision:**

As both the parties have agreed that case be finally disposed of, PIO is thus directed to furnish the requisite givable information to the appellant within 07 days under an intimation to the Commission. Appellant is at liberty to file complaint for non-compliance in case of any contravention by the PIO.

The appeal is accordingly disposed of.
