Brief Facts:

This is a second appeal filed under section 16 (4) of the J&K Right to Information Act, 2009 in the J&K State Information Commission by one Sh. Abdul Rashid Magray S/O. Abdul Gani Magray, R/O. Nowpachi Marwah District: Kishtwar against the alleged non-furnishing of information by the concerned PIO.

The appellant has sought the following information in his original RTI application:

- I. List of Night Chowkidars/Watchmen/Helpers/Sweepers appointed in CA&PD Department till date alongwith their names, copies of appointment orders, place of posting, nature of duty which is supposed to assign them.
- II. Details of salaries/wages withdrawn against each month/year wise till date.
- III. Details regarding present place of posting of all these appointee, departmental status/nature of the post against which these were posted.
- IV. Copy of terms and conditions on the basis of which these appointments were made and the sanctioning authorities thereof.
- V. Name and Designation of the officers/officials who had made the appointment against above mentioned posts.
- VI. Name of the Accountants/Assistants or other if any who had drawn or made payments to Markabans/Night Chowkidars/Helpers/Sweepers.
- VII. Provide carriage rates of food grains from Guzar Inshan to various sale centres of Marwah/Warwan area for the year 2014-2015, 2015-16 alongwith distance.
- VIII. Kindly provide total food grains dispatched to Marwah/Warwan i.e. category wise and Commodity wise for the year 2014-15, 2015-16.
- IX. Kindly mention the total cost of food grains, commodity wise devolved and remitted into Government Treasury with TR Numbers and Dates.

Proceedings:

The case was listed for hearing on today i.e. 13.06.2017. The appellant didn't attend whereas Sh. Bhanu Jasrotia, Advocate, J&K High Court, Jammu attended on behalf of FAA and PIO/Sh. Athar Aameen, Assistant Director,

FCS&CA Department Kishtwar, Jammu and Sh. Firdous Ahmed, Tehsil Supply Officer, FCS&CA Department Marwah and heard through Video Conferencing.

Decision:

The Commission after hearing the parties and going through the papers on record observed that the appellant has sought information on ten points in his original RTI application and the same is also voluminous. In view of the voluminous nature of the information sought by the appellant, it is directed that recourse may be taken to sections 7(9) and 2(i)(i) of the J&K Right to Information Act, 2009 and the appellant allowed to inspect the records. The PIO will take appropriate steps to allow and facilitate the inspection of records.

The second appeal is accordingly disposed of.
