Brief Facts:

This is a second appeal filed under section 16 (4) of the J&K Right to Information Act, 2009 in the J&K State Information Commission by one Sh. Parvez S Shera, R/o. C-6, Channi Apartments, Sector-7, Channi Himmat, Jammu on 26.04.2017 interalia submitting that he had filed an RTI application before the PIO, O/o. ACD, Ramban on 26.11.2016. That the PIO has failed to provide the requisite information within the prescribed time period. That being aggrieved he filed First Appeal dated: 09.01.2017 before the Director, Rural Development Department, Jammu which was

referred to ACD, Ramban by Joint Director (Adm) Rural Development Department, Jammu vide letter dated: 16.01.2017 for considering/deciding the appeal within the stipulated time under the provision of the J&K RTI Act, 2009. That the FAA/ACD, Ramban disposed of the appeal vide order dated: 08.02.2017 with the direction to BDO, Ramsoo to provide the desired information to the appellant free of cost within a week's time. That the PIO/BDO, Ramsoo had failed to provide the requisite information despite direction from the FAA.

Proceedings:

The second appeal was listed for hearing today on 14.06.2017. FAA/ACD, Ramban and PIO/BDO, Ramsoo attended the hearing through Video Conferencing whereas, the appellant attended the Jammu office of the Commission but reached after the conclusion of the Video Conferencing. The appellant informed that he has received the information sought in the RTI application today morning i.e. 14.06.2017 through e.mail.

Decision:

After hearing the parties and the admission of appellant himself regarding receipt of the requisite information by him, there is nothing to be decided further in this second appeal. As such the appeal is disposed of as closed.
