**Final Order**

**Brief Facts:**

This is a second appeal filed under section 16 (4) of the J&K Right to Information Act, 2009 in the J&K State Information Commission by one Sh. Kailash C. Raina, R/o. H.No. 237 B/C Christian Colony, Residency Road, Jammu admitted on 19.05.2017. The appeal is against the alleged non furnishing of the requisite information by the PIO. The appellant in his original RTI application dated: 22.09.2016 has sought the following information from the PIO/Executive Officer, Municipal Committee, Thathri (Doda):

1. Detail of revenue generated for the year 2014 to 2015 and upto September, 2016.
2. Works done from the revenue generated by the Municipal Committee Thathri, District Doda.
3. Payments made on vouchers of the above mentioned years.
4. Detail estimates of the works and technical/estimates approved and the authority to pass the bill of such works.
5. Clearance of Nallahs and Drains, send master sheets alongwith estimates technically checked.
6. How may works were allotted without calling the tenders, amount wise. If works were allotted by calling the tenders, send the paper cutting of the newspapers.

Aggrieved by the alleged non response of the PIO, the appellant preferred First Appeal before the FAA/Director, Urban Local Bodies, Jammu on 05.12.2016 which was disposed of by the FAA vide order dated: 21.01.2017 with the direction to the Executive Officer (PIO) MC, Thathri to provide the information again if not already provided to the applicant as per records under rules within a period of 15 days from the date of receipt of the order.

### **Proceedings:**

In response to the notice of the Commission dated: 03.06.2017 FAA/Sh. Arun Kumar Sharma, KAS Director, Urban Local Bodies, Jammu has filed reply/counter statement vide his letter dated: 12.06.2017 interalia submitting that he had disposed of the First Appeal vide order dated: 21.01.2017 directing the PIO/Executive Officer, Municipal Committee,

Thathri for provision of information again if not already provided to the applicant as per records under rules within a period of 15 days.

The second appeal was listed for hearing on 15.06.2017. The PIO/Executive Officer, Municipal Committee, Thathri was heard through Video Conferencing from Doda whereas FAA/Director, Urban Local Bodies, Jammu and the appellant attended the hearing at Jammu office of the Commission. During the hearing, the PIO submitted that the information sought by the appellant has already been compiled and despatched through ordinary post. The appellant denied receipt of any information till the date of hearing i.e. 15.06.2017.

**Decision/Directions:**

The Commission after going through the record available on file and arguments put forth by both the parties directs the FAA/Director, Urban Local Bodies, Jammu to collect the requisite information from the PIO, Municipal Committee, Thathri within 15 days from the date of receipt of this order and provide the same to the appellant. The appellant is also directed to contact the FAA and receive the information compiled by PIO/Executive Officer, Municipal Committee, Thathri.

The second appeal is accordingly disposed of.
