Decision : Appeal disposed of.

I. Brief facts of the case.

The appellant Sh. Mohammad Rafiq Khan filed 2nd appeal before the Commission under section 16(4) of the J&K RTI Act, 2009 inter alia stating that he had filed RTI application dated 20-05-2016 with the Public Information Officer (PIO), J&K Khadi & Village Industries, Board seeking the following information:

1. Order of appointment of Driver Prithvi Raj.
2. Notification Number and Date under which Driver Prithvi Raj has applied.

That the respondent Department did not provide the information as such he filed 1st appeal with First Appellate Authority (FAA) along with Condonation of delay application through registered post on 17-10-2016. That FAA also did not provide him the requisite information.

II. Proceedings before the Commission.

The case was listed for hearing before the Commission for the first time on 18-04-2017. The case however, was adjourned as the appellant filed application seeking adjournment of the hearing citing serious illness of his mother as a reason.

The case was finally heard before the Commission on 20-06-2017. The hearing was attended by Ms. Nazia Hassan, Advocate, counsel for the respondents and the appellant. Counsel of the respondents submitted that they have already furnished the requisite information to the appellant. She however, handed over the copy of the information to the appellant during the hearing. The appellant received the copy of the information and conceded that his is satisfied with the same and that there is nothing pending now.

III. Decision:

As the appellant has now accepted having received the requisite information, the 2nd appeal needs no further consideration. Therefore, the said 2nd appeal is disposed of accordingly.
