Brief Facts:

The appellant Ms. Tabasum Aziz, D/o. Ab. Aziz Dar, R/o. Zewan Pantha Chowk, Srinagar while exercising her right to information filed RTI application with PIO, J&KSSRB on 18.05.2016 seeking information on 03 points regarding examination for the post of Junior Dental Technician, District Srinagar under notification No. 06 of 2015. Aggrieved by the inaction of the PIO, she filed First Appeal on 18.06.2016 with the Secretary, J&KSSRB. At last, she approached the Commission by filing the 2nd appeal against the above mentioned respondents which was finally admitted in the Commission on 10.03.2017.

Proceedings:

The case was for the first time listed before the Commission on 22.03.2017. The hearing was attended by Sh. Ab. Rashid Dar, PIO, J&KSSRB. The case was adjourned as the appellant filed application for adjournment of the hearing.

The case was again listed before the Commission today on 29.06.2017 for final hearing which was attended by Sh. Hamidullah Shah, PIO and Sh. Peer Mohd. Shafi, Senior Assistant, J&KSSRB. The appellant did not appear despite advance notice through prescribed mode of service. During the hearing, PIO submitted that all the information has been obtained by the appellant from the concerned agency. PIO submitted copy of the said information which was sought by the appellant.

Decision:

As the appellant neither appeared in the hearings nor submitted any rejoinder, as such the Commission finds no reason to disbelieve the assertion of the PIO that information sought by the appellant has been collected by her. A fresh copy of the information already provided may be sent to the appellant by registered post. Appellant is at liberty to file complaint in case she did not receive information in compliance to the Commission's directions.

The appeal is accordingly disposed of.
