Brief Facts:

The appellant Sh. R.D. Singh Bandral, Advocate R/o. H. No. 86-B, Lane No. 12, Bhawani Nagar, Janipur, Jammu while exercising his right to information filed RTI application with PIO/Chief Education Officer (CEO), Doda on 25.02.2017 (through post) seeking information on 03 points as under:

- (i) *Kindly provide the information as to which advertisement no. and date, the candidates in District Doda were appointed as class IV employees, vide Government Order No. 440 Edu of 2010 dated: 13.05.2010.*
- (ii) *Kindly provide the list of candidates who had applied for class IV post in the Education Department in District Doda by virtue of advertisement No. 1/98*

dated: 21st of April 1998 though cancel and re-advertise vide fresh advertisement no. 1 of dated 26.09.2000.

(iii) Kindly provide the detailed reply pertaining to aforementioned queries, if any.

Aggrieved by the non response of the PIO, he filed First Appeal on 18.04.2017 (received on 19.04.2017) with the FAA, O/o Directorate of School Education, Jammu. The FAA/Joint Director (SSA), Directorate of School Education, Jammu disposed of the First Appeal vide his order dated: 11.05.2017. At last, he approached the Commission by filing the 2nd appeal against the above mentioned respondents which was finally admitted in the Commission after completion of deficiencies on 22.08.2017.

Proceedings:

In compliance to the notice of the Commission dated: 04.10.2017, the hearing was attended by Dr. Des Raj Bhagat, Personnel Officer, O/o Director, School Education, Jammu (on behalf of FAA) and Sh. Mohammad Sharief, CEO, Doda-cum-PIO. The appellant did not attend.

During the course of hearing CEO, Doda-cum-PIO filed counter statement to the 2nd appeal.

The PIO/CEO, Doda reiterated the same facts as cited in the reply to the appellant communicated vide his letter No. CEO/D/RTI/10143-44 dated: 18.07.2017 wherein it is shown that on the directions of Hon'ble High Court of J&K and with the approval of Director, School Education Jammu and District Development Commissioner, Doda eight number of candidates were appointed.

Decision:

In view of the above information provided by the PIO and records seen, it is observed that since the requisite information has already been provided to the appellant by the PIO/CEO, Doda, there is nothing left to be decided further.

With these observations the second appeal is disposed of.
