Decision : Appeal disposed of.

Facts:

Briefly the facts of this case are that the appellant while exercising his Right to Information filed RTI application dated 20-04-2017 with Public Information Officer, (PIO) J&K Service Selection Board (SSB) seeking the following information:

1. Kindly provide the information that how many posts were advertised for Physical Education teacher District Cadre Poonch item No. 724 advertisement No. 9/2013 for District Cadre Poonch under OM category and also provide information regarding the status of above mentioned posts.
2. Kindly provide the marks sheet of Arif Mateen S/o Mohammad Hussian R/o Khanater Tehsil Haveli District Poonch under Roll No 1311600198 of Physical Education written test as well as viva-voice, which was conducted by SSRB Jammu.
3. Kindly provide the information regarding the cut of point of physical education teacher under open category of district cadre poonch and merit list of the selected candidates under open category District Poonch.
4. Kindly provide the answer sheet of Arif Mateen S/o Mohammad Hussian R/o Khanater Tehsil Haveli District Poonch under Roll No 13116001998
5. Kindly provide the games certificates and qualification certificates of selected candidates acquires by them and marks awarded for such certificates under open category

As the PIO did not furnish to him the requisite information, the appellant filed 1st appeal with First Appellate Authority (FAA) on 29-05-2017. FAA too failed to dispose of his 1st

appeal constraining him to file 2nd appeal which was received on 24-07-2017 in the State Information Commission (SIC). The appellant requested the SIC to direct the PIO to provide him the requisite information sought by him in his RTI application.

Proceedings before the State Information Commission(SIC):

The case was listed for hearing before the SIC on 24-10-2017. The hearing was attended by Sh. A.R. Bhat, PIO J&K, SSB. The appellant however did not cause his appearance through video conferencing from Jammu office of the SIC despite due notice. The PIO submitted that information on points 1 to 4 of the basic RTI application was provided to the appellant vide their office communication No. SSB/Adm/RTI/226/17/585 dated 24-08-2017 and the balance information on point 5 that was available in the Divisional Office, Jammu was provided to him on 01-09-2017. The PIO submitted the copies of the said communication, which were taken on record.

Decision:

In the light of the available record and the submissions made by the PIO, it transpires that whole of the information sought by the appellant has been provided to him and as such the matter in hand needs no further consideration.

With these observations the 2nd appeal is therefore, disposed of.
