**Final Order**

**Facts:**

Briefly the facts of this case are that appellant filed RTI application dated 20-02-2017 with Public Information Officer, (PIO), J&K Service Selection Board (J&K SSB) seeking information regarding action taken on his representation dated 05-04-2016 filed with J&K SSB.

As the appellant did not get information from the PIO, he filed 1<sup>st</sup> appeal with Chairman, J&K SSB on 28-03-2017 against the inaction of the PIO. Finally the appellant approached State Information Commission (SIC) in 2<sup>nd</sup> appeal which was admitted in the SIC on 04-07-2017. The appellant alleged that he has not been provided information either by the PIO or by FAA. He requested the SIC for provision of information.

**Proceedings before the Commission on 20-10-2017:**

1. The case came up for hearing before the SIC today on 20-10-2017.
2. The hearing was attended by Sh. Abdul Rehman Bhat, PIO J&K SSB. The appellant was heard through video conferencing from Jammu office of the Commission.
3. Appellant reiterated his request for provision of information.

4. PIO submitted that the information has now been sent to the appellant vide letter dated 16-10-2017. He submitted the copy of the same with the Commission.

**Directions:**

***As the information stands provided to the appellant now, nothing remains for any further consideration in the appeal.***

**The 2<sup>nd</sup> appeal is accordingly disposed of.**
