Brief Facts:

The brief facts of this 2nd appeal are that the appellant Muhammad Ashraf Bhat has filed the 2nd appeal before the Commission on 16-08-2017 against the First Appellate Authority (FAA)/Public Information Officer (PIO) EM&RE Wing Kashmir alleging therein that the PIO has failed to provide the information to the appellant sought vide RTI application dated 16-03-2017. Thereafter, the appellant filed first appeal before

FAA on 20-04-2017. After filing of the first appeal, the PIO responded his RTI application vide letter dated 15-05-2017 providing part of the information.

Not satisfied with the information provided, the appellant filed the instant 2nd appeal before the Commission. On scrutiny of documents, some deficiencies were found which the appellant got completed on 15-09-2017 and accordingly, the 2nd appeal was admitted on the said date.

The 2nd appeal came up for hearing on 01-11-2017 and on the said date, the PIO submitted that he has provided the information to the appellant and has also addressed a communication No. CE/M&RE/25351-53 dated 26-08-2017 whereby appellant was asked to attend the office so that remaining information, if any, will be provided to him. But the appellant did not attend his office. As the appellant had not attended the Commission on 01-11-2017, as such, the hearing in the 2nd appeal was adjourned with directions to the appellant to substantiate as to what information has not been provided to him, failing which necessary orders shall follow.

The 2nd appeal again came up for hearing today but nobody appeared before the Commission. The appellant was therefore contacted on phone today by the registry of the Commission and the appellant informed that he has been provided full information as sought by him in his RTI application under consideration, The appellant accordingly requested the Commission for disposal of the 2nd appeal as he

is satisfied with the information provided and has no further cause of agitation.

As the grievance of the appellant has been redressed by providing him the remaining information, as has been admitted by him on telephone, there remains nothing to adjudicate in this appeal. The 2nd appeal is accordingly disposed of.
