**Brief Facts:**

Briefly the facts of this appeal are that the appellant approached the Public Information Officer, (PIO) J&K Service Selection Board (SSB) with RTI application dated 19.06.2017 seeking the following information:

1. The details of technical and non-technical qualification of the shortlisted candidates of District Pulwama who applied in case of open-merit for the post of Junior physiotherapy in any form.
2. The percentage of marks of the above mentioned enlisted candidates in the examination for the post of Junior Physiotherapy in which they have been shortlisted.

The PIO did not respond to his RTI application within the stipulated time as such appellant filed 1<sup>st</sup> appeal with the First Appellate Authority (FAA) on 24-07-2017. The FAA too failed to dispose of his first

appeal which constrained the appellant to approach the State Information Commission (SIC) in 2<sup>nd</sup> appeal, which was received on 11-09-2017.

In the 2<sup>nd</sup> appeal the appellant requested the SIC for provision of the information sought by him through his basic RTI application.

**Proceedings before the State Information Commission(SIC):**

The appeal came up for hearing before the SIC on 09-11-2017. The hearing was attended by Dr. Rehana Akhtar Bijli, PIO and Sh. Hamidullah Bhat for respondents. The appellant along with his counsel also appeared.

During the hearing the appellant submitted that the requisite information sought for by him has not been provided to him so far. The SIC enquired from the PIO as to whether the selection process now is completed as the then PIO, J&K SSB vide his communication dated 11-08-2017 had informed the appellant that selection list has not been framed as yet as such the cut off marks for the shortlisted candidates can only be provided after the completion of the whole process. The appellant however, informed that selection process has now been completed. The PIO too accepted the assertion of the appellant.

Both the parties were heard and record was also perused.

**Decision:**

***The SIC directs the PIO, J&K SSB to provide the list of shortlisted candidates belonging to District Pulwama along with all their educational qualifications( Technical , non-technical and marks etc) to the appellant within 10 days from the date of receipt of this order.***

***Therefore, 2<sup>nd</sup> appeal is disposed of subject to the above directions.***
