Brief Facts:

Briefly the facts of this complaint are that the complainant approached the State Information Commission with a complaint under section 15 of the J&K RTI Act, 2009 alleging that the Public Information Officer, (PIO) J&K Service Selection Board (SSB) failed to furnish the information sought by him through his RTI application dated 19.06.2017 and requested the SIC to look into the matter.

Proceedings before the State Information Commission(SIC):

The complaint came up for hearing before the SIC on 10-11-2017. The hearing was attended by Sh. Ishwar Dutt, PIO who verbally submitted that the PIO could not attend due to her ailing health condition. The complainant did not attend.

On perusal of the documents it was noticed that complainant has filed an application with the SIC received on 12-10-2017 stating therein that she has received all the information as such her grievance has now been redressed and therefore, she is withdrawing her complaint.

The SIC observed that PIO has responded to the RTI application on 10-02-2017 and 17-02-2017. APIO also submitted that requisite information stands provided to the complainant.

Decision:

The SIC finds no legal impediment in acceding to the request of the complainant for withdrawal of the complaint with the rider that complainant is debarred from approaching the SIC again on the same matter.

Therefore, the instant complaint is disposed of as withdrawn.
