Brief Facts:

Briefly the facts of this appeal are that the appellant approached the Public Information Officer, (PIO) J&K Service Selection Board (SSB) with RTI application dated 17.04.2017 seeking the following information:

1. That how many candidates have been selected from parent districts under SC quota in two districts of the State of J&K i.e Rajouri & Reasi from the year 2013 t till date.
2. That how many candidates were selected from other districts in district Rajouri and Reasi respectively under SC Inter- District policy from 2013 to till date.
3. That whether there is any rule of giving priority to the candidate of the parent district under SC quota in inter district recruitment policy.
4. That to provide me the copy of the SC Inter-District recruitment policy.

The PIO vide communication dated 26-04-2017 informed the appellant that mode of fee deposited by him is not as per J&K RTI Rules, 2012. The reply of the PIO did not satisfy the appellant as such he filed 1st appeal with First Appellate Authority (FAA), J&K SSB on 25-05-2017. The FAA failed to dispose of 1st appeal which constrained the appellant to file 2nd appeal before the State Information Commission (SIC) on 20-07-2017.

Proceedings before the State Information Commission(SIC):

The appeal came up for hearing before the SIC on 07-11-2017. The hearing was attended by Dr. Rehana Akhtar Bijli, PIO J&K, SSB. The appellant did not appear despite due notice.

During the hearing the PIO stated that all the requisite information stands provided to the appellant on 06-10-2017. She submitted copies of counter reply and reply of the PIO in support of her arguments which was taken on record.

Decision:

After hearing the PIO and upon perusal of the record it transpires that information sought by the appellant has been furnished to him.

In view of this SIC finds no reason to disbelieve the assertion of the PIO.

Therefore, 2nd appeal is disposed of as it needs no further consideration.
