#### Facts:

Briefly the facts of this 2<sup>nd</sup> appeal are that the appellant while exercising his right to information under the J&K RTI Act, 2009 filed RTI application dated 20-02-2017 with the Public Information Officer(PIO) O/o Joint Director Information in the Directorate of Information & Public Relations Department J&K seeking following information:

- 1. According to which eligibility criteria advertisements are issued whether by 1996 or 2016 policy.
- 2. During the unrest period in Kashmir Valley June 2016 how many newspapers were not published during the turmoil period, how many advertisements are issued to that newspapers, those newspapers which were not published during turmoil period, according to which policy advertisement are issued in favor of those newspaper.
- 3. What is the Budget policy of Local newspapers and national newspapers in 2014-2016 of advertisement.
- 4. What is the budget criteria in 2014-2015 same as 2015-2016.
- 5. How the Liability raises
- 6. Under which criteria, policy advertisements are issue only in two newspapers.

As per the records, the PIO did not reply the RTI application in time within thirty days as per section 7(1) constraining the appellant to file  $1^{st}$  appeal with the First Appellate Authority (FAA) O/O Directorate of Information & Public Relation, J&K Government on 29-03-2017. The appellant as a last resort approached the State Information Commission (SIC) in  $2^{nd}$  appeal against the inaction of the above said authorities. His  $2^{nd}$  appeal was admitted in the Commission on 10-07-2017.

### **Proceedings before the Commission:**

- 1. The 2<sup>nd</sup> appeal came up for hearing before the State Information Commission (SIC) on 18-10-2017.
- 2. The hearing was attended by Sh. Zahoor Ahmad, Joint Director/FAA and appellant Sh. Arshid Rasool. PIO did not appear because of his transfer, as reported.

FAA stated that the information sought by the appellant stands provided to the appellant by the Deputy Director, Information (PR), Srinagar vide letter bearing No. RTI/PR/K-1001/2017 dated 25-04-2017.

- 3. The appellant also conceded to have received the same. The appellant however, insisted on provision of more details in this regard.
- 4. The Commission after perusal of his RTI application found that information provided to him was actually in accordance with the contents of the RTI application. The appellant was informed that the PIO is obliged to provide him the same information which he has sought through the RTI application and that he is not obliged to provide details unless specifically sought.

### **Decision:**

After hearing the parties and perusal of the record, SIC finds that the information as per the RTI application stands provided to the appellant and therefore, the matter needs no further consideration. However, the PIO shall ensure that in future reply to the RTI applications is provided within time as stipulated under section 7(1) of the Act and that the FAA shall also ensure to dispose of the 1<sup>st</sup> appeal in terms of section 16(7) of the Act.

#### The 2<sup>nd</sup> appeal is accordingly disposed of accordingly.
