### **Proceedings before the State Information Commission(SIC):**

The 2<sup>nd</sup> appeal came up for hearing before the SIC on 04-12-2017. The hearing was attended by Sh. Bhaskar, SO(P), BDO office, Changa on behalf of the Public Information Officer (PIO)/BDO Changa.

The representative for PIO submitted that the requisite information as sought by the appellant vide RTI application dated 19-04-2017, stands provided to him. The appellant acknowledged that the requisite information has been received vide receipt dated 31-08-2017 and also submitted an affidavit as acknowledgement of information received.

### **Decision:**
