**Facts:**

The appellant has filed an RTI application in the office of the PIO/CEO Poonch on 22-08-2017. The CEO, Poonch further transferred the RTI application to the ZEO, Mendhar on 25-09-2017. Having not received any reply, the appellant filed the 1<sup>st</sup> appeal before the First Appellate Authority (FAA) O/o the Directorate of School Education, Jammu on 06-10-2017, but the FAA has failed to pass any order. As such, prayed before the Commission for directing the PIO for providing the requisite information.

**Proceedings before the State Information Commission (SIC):**

The FAA and ZEO, Mendhar were present for hearing and the appellant did not cause his appearance despite due notice. The ZEO, Mendhar placed on record the counter reply of the CEO, Poonch where under the CEO Poonch submitted that the requisite information has been provided to the appellant by the ZEO, Mendhar on 27-10-2017 against a proper receipt. A copy of the receipt is also enclosed with the counter reply, which confirms the fact that the appellant has actually been provided with the information.

**Decision:**

*The Commission viewed that since the appellant has received the requisite information there left nothing to be decided upon in the 2<sup>nd</sup> appeal. Hence, the 2<sup>nd</sup> appeal is disposed of without any further direction.*
