Brief Facts:

Briefly, the facts of this case are that the appellant Sh. Safder Ali Mir, while exercising his right to information filed an RTI application with the Public Information Officer (PIO) Chief Education Officer, Doda on 01-07-2017 seeking information regarding 10th and 12th class marks sheets of selection list candidates class IV in school education department, District Doda of reference Notification No. 1 of 2011 dated 02-02-2011 (with their Diploma).

Proceedings before the State Information Commission(SIC):

The instant 2nd appeal was listed for hearing before the State Information Commission today on 08-02-2018. The hearing was attended by Sh. Darsham Lal First Appellate Authority (FAA) School Education Department, Jammu and the appellant. The FAA submitted that the information sought for by the applicant has been provided to the appellant. However, the appellant stated that he had sought 10th and 12th class marks sheets of selected candidates. Against 98 selected candidates he has been provided the marks sheets only of 71 candidates. The FAA stated that he will provide the rest of the information to the appellant after he points out the deficiency.

Decision:

The appellant is accordingly directed to inform the PIO the deficiency in the information provided and the names of the candidates whose marks sheets have not been received so that same is provided to the PIO within the period of 10 days.

The appeal is accordingly disposed of.
