**Final Order**

The brief facts of this 2<sup>nd</sup> appeal are that the appellant Mr. Syed Muhammad Yaseen filed the RTI application dated 19-07-2017 seeking certain documents mentioned in the said application. As no information was provided by the Public Information Officer (hereinafter for short as 'the PIO'), the appellant filed first appeal on 19-08-2017 with

FAA/Superintending Engineer, Irrigation & Flood Control Department, Shopian. As the FAA failed to dispose of the first appeal, the applicant filed this appeal before the State Information Commission.

On the last date of hearing on 25-01-2018, the PIO had submitted that they had taken up the matter with the revenue department for collecting necessary details and now he has collected the entire information sought by the appellant. A revised reply has been formulated and would be furnished to the appellant within a period of ten days. The appeal was accordingly adjourned with direction to the PIO to furnish the information to the appellant within ten days with direction to the appellant to go through the reply so furnished by the PIO and file a rejoinder by the next date of hearing.

This 2<sup>nd</sup> appeal again came up for hearing today on 20-02-2018. The hearing was attended by Mr. Syed Muhammad Yaseen, appellant, Engr. Naim Ahmad Naim, FAA/I&FC Shopian and Engr. G. H. Sofi, PIO/Ex. Engineer, F. C. Division Kakapora, Pulwama. The PIO submitted that all the information sought by the appellant vide RTI application dated 19-07-2017 has been furnished to the appellant. The appellant acknowledged the receipt of the

information and submitted that he is satisfied with the information provided to him by the PIO. As such, there remains nothing to be adjudicated in this 2<sup>nd</sup> appeal. The appeal is therefore, disposed of.
