Final Order

The brief facts of this 2nd appeal are that the appellant Mr. Bilal Ahmad Kar had filed the RTI application dated 11-07-2017 seeking various documents mentioned in ten (10) points in the said application from the respondents. As no information was provided by the Public Information Officer, the appellant filed first appeal on 17-08-2017 with FAA/Managing Director,

J&K Housing Board, Srinagar which was heard the FAA on 12-09-2017. During the hearing of the 1st appeal, the FAA directed the PIO to furnish the detailed information as sought by the RTI applicant within a period of ten days. The PIO though provided the information to the appellant but the same was found misleading /inadequate by the appellant who then approached the State Information Commission in 2nd appeal on 12.10.2017

On the last date of hearing before the Commission on 01-02-2018, the PIO submitted that the information sought for has been provided to the appellant by the Deputy General Manager Housing Board Unit-III Srinagar vide communication dated 30-01-2018 in pursuance to the Commission's interim order dated 11-12-2017. The appellant also confirmed to have received the said information. However, the appellant stated that he has received the information one day before and therefore, is yet to go through it so as to see whether it is as per his basic RTI application or not. He sought some more time for filing the rejoinder. The case was therefore, adjourned to 09-02-2018 to be heard at Srinagar office of the Commission.

The case was again listed before the Commission on 09-02-2018. Mr. Bilal Ahmad Kar, appellant and Mr. Aijaz Ahmad Executive Engineer, J&K Housing Board, Srinagar and Bashir Ahmad Mir, AEE Housing Board, Srinagar were present in the Srinagar office of the Commission whereas Mr. Manmohan Singh, M.D. J&K Housing Board/FAA, Mr. Yogesh, Senior Programmer, J&K Housing Board/PIO and Mr. Aftab Ahmad

Pandith, Executive Engineer, J&K Housing Board Unit-II were heard through Video Conferencing. The PIO submitted that all the information sought by the appellant vide RTI application dated 11-07-2017 has been furnished to the appellant as had been stated on the last date of hearing on 01.02.2018. The appellant acknowledged the receipt of the information and submitted that he is satisfied with the information provided to him by the PIO. In view of the circumstances, the 2nd appeal filed before the Commission is accordingly disposed of and closed.
