Proceedings on 09-04-2018:

The second appeal came up for hearing today on 09-04-2018 at Srinagar office for hearing through Video/teleconferencing from Jammu. The appellant Shri Karam Chand and Shri Rajinder Singh, Tehsildar Bhalwal were heard through teleconferencing as

Video Conferencing could not be held due to some technical problems.

The appellant stated that the PIO/Tehsildar Bhalwal had not implemented the orders of FAA/SDM, Jammu North. However, the respondent-PIO/Tehsildar Bhalwal stated that information as directed by FAA/SDM, Jammu North has been provided to him. He also stated that the actual grievance of the appellant is that he wants an approach road to be opened but the approach road does not exist in revenue records.

Direction:

The Tehsildar will now provide the uptodate action taken report in detail as has been requisitioned by the RTI applicant and with reference to the directions of SDM referred to therein and also submit a copy of the report to the SDM (North)/D.C. Jammu for redressal of grievances of the applicant as per law. With this direction, the second appeal is disposed of.
