**Final Order**  
**(Complaint for non-compliance)**

**Brief Facts:**

The complainant Sh. Sikander Singh, R/o. VPO Hamirpur Sidhar, Tehsil Khour, District Jammu-181283 filed the present complaint against the PIO/Tehsildar, Khour for non-compliance of the decision dated: 14.06.2017 passed by the State Information Commission (SIC) in 2<sup>nd</sup> appeal titled Sh. Sikander Singh v/s FAA/SDM, Khour and PIO/Tehsildar, Khour. The complainant in the complaint had submitted that he had applied for inspection of record but no response had been received from the respondents. Accordingly, he has requested the Commission for taking action against the PIO.

## **Proceedings:**

The complaint was taken up for hearing for the first time on 19.01.2018. The hearing was attended by Sh. Ramesh Chander, Tehsildar, Khour. The complainant didn't attend. The PIO/Tehsildar, Khour submitted that the complainant (the then appellant) was intimated vide notice/letter dated: 31.08.2017 to visit his office during working hours and inspect the Despatch Register of ALC Certificates and other record but he failed to come for the same. The PIO further submitted that he has no objection to the inspection of record by the complainant. Accordingly, the hearing was adjourned with the following directions:

***"In view of the absence of the complainant and in order to provide him another opportunity of being heard, the hearing of this complaint is adjourned. The complainant is directed to attend on the next date of hearing for presenting his arguments."***

The complaint again came up for hearing today on 03.04.2018. The hearing was attended by the PIO/Tehsildar, Khour and the complainant.

The complainant submitted that he has received the intimation letter of the PIO/Tehsildar, Khour regarding inspection of record and he is going to inspect the record personally within a few days.

## **Decision:**

**In view of the satisfaction expressed by the complainant regarding opportunity provided to him by the PIO for inspection**

**of record, there is nothing before the Commission to decide further. Therefore, this complaint is disposed of as closed.**

*With these directions the complaint is disposed of.*
