Brief Facts:

The applicant Sh. Shagundeeep Singh filed RTI application before the PIO O/O Regional Transport Officer, Lakhanpur, Kathua, J&K seeking certain information with regard to details of the penalty imposed on overloaded fresh fruit trucks passing through Lakhanpur toll post on 09-10-2017, 10-10-2017, 11-10-2017, 13-10-2017, 17-10-2017 and 18-10-2017. The vehicles have been identified by the applicant in his RTI application along with the gross vehicle weight. However, the PIO did not provide any information to the applicant and he filed the 1st appeal before the First Appellate Authority (FAA). On failure of the FAA to dispose of

the 1st appeal, the applicant filed the 2nd appeal before the State Information Commission (SIC).

Proceeding/Decision:

The instant appeal came up for hearing before the SIC today on 23-04-2018. The appellant was present in person. Mr. Mohinder Singh Additional Transport Commissioner/FAA was also present. However, the PIO was not present owing to some official engagement for which he has sought exemption from appearance. The FAA submitted that he had asked the appellant to appear for hearing in the appeal but the appellant did not attend. As such, the appeal remained un-disposed of. The appellant submitted that he could not attend due to untimely death of his uncle. Since the 1st appeal filed by the appellant was not disposed of by the FAA, it would, in the circumstances, be just and proper to remit back the case to the FAA with a direction to dispose of the 1st appeal filed by the appellant after hearing both the PIO as well as the appellant.

This appeal is accordingly remitted back to First Appellate Authority for disposal of the 1st appeal filed by the appellant in accordance with the provisions of the J&K RTI Act, 2009.
