### **Brief Facts:**

The applicant has filed the RTI application on 28-07-2017 before the Public Information Officer (PIO)/Assistant Director CA&PD Department, Kathua. On not receiving any reply from the PIO, the applicant filed the 1<sup>st</sup> appeal on 05-09-2017 before the First Appellate Authority (FAA)/Director CA&PD, Jammu. On the direction of the FAA, the PIO has provided a reply to the RTI application on 26-10-2017. Terming the information provided by the PIO as wrong, the applicant came before the State Information Commission by way of filing 2<sup>nd</sup> appeal on 27-12-2017.

### **Proceeding/Decision:**

The appeal came up for hearing before the State Information Commission (SIC) on 09-02-2018. The hearing was attended by Sh. Ajaz

Saleem PIO, CAPD, Ms Hema Choudary Advocate, counsel for respondent, Ms. Monika Kohli, Prosecutor PCS, CAPD and the appellant. The hearing was adjourned with the directions to the PIO to provide the revised information to the appellant by or before the date of next hearing containing the details of the allotment of K.oil to all the dealers in Rural Kathua from 01-10-2016 to 30-06-2017, the information with regard to sugar supplied in connection with Eid festival 2017 and also the details with regard to casual, contingent, contractual and daily wagers working in CAPD Kathua with their engagement orders.

The appeal again came up for hearing before the SIC on 03-04-2018. The appellant was not present. However, the representative of the PIO as well as of FAA were present. The representatives of the respondents placed on record communication of Assistant Director, FCS&CD, Department Kathua addressed to the Commission stating that information has been provided to Sh. Paramjit Singh (appellant). They also furnished a copy of affidavit sworn by the appellant deposing therein that he has received the information from the PIO and he is satisfied with the same. The appellant further deposes in the said affidavit that he wants to withdraw the appeal.

Since the appellant has received the information asked for and as such he wants to withdraw his appeal, the 2<sup>nd</sup> appeal filed by the appellant is dismissed as withdrawn.
