FINAL ORDER

The present appeal has been filed by the appellant on 01-01-2018 on the ground that the PIO had not furnished him the information as sought by him through his RTI application dated 07-10-2017 and praying therein that the PIO be directed to provide the required information to the appellant. The appeal came up for hearing before the Commission on 24-04-2018. The appellant did not

attend the hearing. The PIO/BDO, Trigam appeared before the Commission and submitted that the entire information has been provided to the appellant and that the appellant is satisfied with the information. The PIO also furnished a copy of the receipt signed by the appellant acknowledging the receipt of information and and expressing his satisfaction about the same. Since the appellant was not present, the hearing was adjourned with a view to provide an opportunity to indicate if he was interested in persuing the appeal any more.

The appeal again came up for hearing on 23-07-2018. The PIO/ BDO, Trigam was present while appellant again did not attend. However, the BDO submitted a receipt signed by the appellant Mohd. Ashraf in presence of the witness Sh. Arshad Ahmad stating that he has received all the information as sought by him on 16-03-2018 from the PIO and that he is totally satisfied with the same. In view of the fact that the appellant has received the information and also the fact that he choose not to appear before the Commission on two consecutive hearings, it can safely be assumed that the appellant does not want to pursue this appeal any further. The appeal is accordingly disposed of.
