BRIEF FACTS:

The present appeal has originated out of RTI application dated 29-11-2017 filed by the appellant Shri Shagundeeep Singh with PIO/Deputy Commissioner Excise, Toll Post Lakhanpur, Kathua, J&K seeking certified toll permits/receipts (RT-4) and assessment receipt (RT-2) of various trucks entering into Jammu & Kashmir passing through Lakhanpur import side toll post. Since no information

was provided to him by the PIO within the stipulated time, he filed first appeal with Deputy Excise Commissioner, Toll Post Lakhanpur, Kathua, J&K praying for a direction to the PIO to provide the requisite information without any further delay. The appellant finally filed second appeal before the State Information Commission on 01-05-2018 contending that the first appellate authority did not dispose of the first appeal filed by him nor has the PIO provided any information to him till that date.

The 2nd appeal came up for hearing before the SIC on 24-07-2018. The parties were present during the hearing and after hearing the parties, the appeal was adjourned with a direction to the PIO/ETO, Toll Post Lakhanpur, Kathua, J&K to provide the information to the appellant in the form and in the manner it is available with the public authority within a period of three weeks from today.

The appeal again came up for hearing before the Commission today on 28-08-2018. Nobody was present. However, the PIO has filed a statement of facts dated 22-08-2018 before the registry of this Commission stating therein that the information sought for by the appellant has been furnished to him and in support of his contention, the PIO

has also annexed a certificate issued by the appellant whereby the appellant has admitted that in compliance to the interim order passed by this Commission, he has received the information sought by him vide his RTI application dated 29-11-2017 in respect of para 1 and the appellant is fully satisfied with the record provided to him.

Since the information sought by the appellant has been provided to him and the appellant has expressed his satisfaction with the said information, nothing further remains to be adjudicated upon in the instant 2nd appeal.

The 2nd appeal is accordingly disposed of.
