**Brief Facts:**

The present appeal has been filed by the appellant Sh. Paras Ram on 28.05.2018 (admitted on 19.07.2018) submitting thereunder that he had filed an RTI application on 22.01.2018, seeking some information from the PIO/BDO, Mahanpur. When the PIO failed to provide information, he filed First Appeal on 26.02.2018. The appellant has further submitted that the FAA did not dispose of his First Appeal within the stipulated period. Thereafter, he filed the present second appeal.

## **Proceedings:**

The appeal came up for hearing before this Commission today on 26.09.2018. FAA/Sh. Sukhpal Singh, AC (D), Kathua and PIO/Sh. Joginder Lal, BDO, Mahanpur attended the hearing. The appellant did not attend the hearing in spite of due notice. However, he has filed a written statement dated: 25.09.2018, whereunder he has submitted that he has received the information sought by him from the PIO and that he is satisfied with the information received. He accordingly requested for disposal of his appeal.
